1. Item no. 4200 Page C44 – Following discrepancies on asphalt thickness in the bill and the excel BOQ. **Note that asphalt thickness is 40mm**. *Substitute with the attached item 4200 pg. No.C44*. Note the changes in the BOQ highlighted in **BOLD** and similarly the excel BOQ descriptions changed to align the descriptions.
2. **Electrical BOQ pg. 56** – item 5.1.1. Note the transformer size is **4 No.50KVA** transformers and not ~~4 No.16KVA~~
