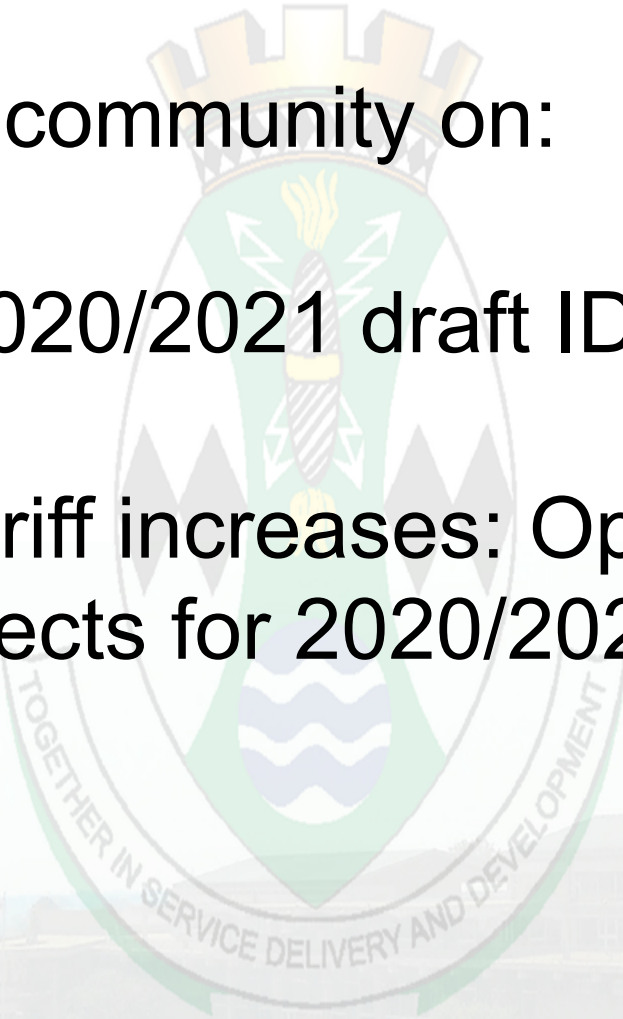




# PURPOSE OF THE MEETING

To consult the community on:

- Municipal 2020/2021 draft IDP and Budget
- proposed tariff increases: Operational and Capital Projects for 2020/2021 FY





# INTRODUCTION (BUDGET ASSUMPTIONS)

- The impact of Covid-19 pandemic on municipal socio-economic profile (LED, unemployment, poverty, revenue enhancement and budget)
- Reprioritisation of the budget as a response to Covid-19 e.g.: water, sanitation and LED (Local Economic Development)
- Proposed tariff increase linked to inflation rate
- Successful implementation of municipal revenue enhancement strategies and cost curtailment measure through implementation of Municipal Financial Recovery Plan.
- Introduce conservation fees to encourage consumers to preserve water and electricity (the more you use, the more you pay) .
- Budget is based on 70% projected collection rate

# BUDGET MAIN CHALLENGES FOR 2020/2021

- Unemployment rate
- Closure of Businesses (impact of Covid-19 lockdown)
- Exponential population growth vs low economic growth
- Service delivery backlog (water, electricity and housing)
- Ageing infrastructure and high distribution losses
- Vandalism and theft of municipal assets
- Low payment rate



# OPERATING REVENUE FOR 2020/2021

- Budgeted revenue for 2020/2021 is **R3,7billion**, showing an increase of **7,9%**.
- This increase is attributed to the following:
  - Tariff increase of 4,9% on service
  - The principle of the more you use, the more you pay.
  - Additional billed properties and reducing of a property rates discount from 40% to 35%.
  - An increase of 8.1% on electricity tariff subject to NERSA approval.
  - Other national government grants

# OPERATING EXPENDITURE BUDGET for 2020/2021

- The operational budget provides for the total operating expenditure for 2020/2021 financial year for **R4,5billion**.
- To cover the following:
  - Employee related cost;
  - Bulk purchases(Electricity and Water);
  - Payment on interest on Eskom account; and
  - Infrastructure maintenance cost:
    - Water treatment plan;
    - Roads;
    - Landfill site,
    - Financial system;
    - Provision of Security;
    - Transportation of Portable Water

Property rates	5.20%	4.9%	<ul style="list-style-type: none"> <li>The property rates will be levied on the total market value of the property in accordance with the Property Rates Policy.</li> <li>The first R50,000 of the market value of residential properties will be exempted from property rates and an additional 35% discount of the value of the property.</li> <li>The 40% discount has been reduced to 35% to enhance the property rate revenue.</li> </ul>
Electricity	13.81%	8.1%	<ul style="list-style-type: none"> <li>As per the NERSA's approval in 2019.</li> <li>Awaiting final approval from NERSA.</li> <li>Incline block tariffs will be introduced (the more the usage the more the price)</li> </ul>
Water	10.45%	4.9%	<ul style="list-style-type: none"> <li>Introduction of a water conservation fee on residential to encourage saving of water and to discourage the abuse of water. The water conservation fee will be implemented on a incremental block tariff basis, meaning that the more the usage of water, then the higher the price or fee.</li> <li>The water conservation fee will be triggered when consumption is 31kl and more.</li> </ul>
Sanitation	9.40%	4.9%	<ul style="list-style-type: none"> <li>Sewer levy is based on water consumption. In 2020/2021 financial year Sewerage levy will be limited to a maximum of 60% of water consumption for residential only.</li> </ul>
Refuse	14.54%	4.9%	<ul style="list-style-type: none"> <li>The refuse removal service tariff is mainly affected by a high labour component, the petrol price increase above the inflation and an increase in vehicle maintenance of refuse vehicles.</li> </ul>
