INVITATION TO PARTICIPATE IN THE PUBLIC PARTICIPATION PROCESS

THE NATIONAL ENVIRONMENTAL CONSULTATIVE AND ADVISORY FORUM APPOINTED IN TERMS OF SECTION 3A OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT NO. 107 OF 1998) (NEMA) TO ADVISE THE MINISTER OF FORESTRY, FISHERIES AND THE ENVIRONMENT ON MATTERS ARISING FROM APPLICATIONS FOR THE SUSPENSION AND POSTPONEMENT OF COMPLIANCE WITH THE MINIMUM EMISSION STANDARDS AND THE APPLICATIONS FOR THE ISSUANCE OF PROVISIONAL ATMOSPHERIC EMISSION LICENCES

Section 24 of the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996) provides for the right to an environment that is not harmful to the health or well-being of people and to have the environment protected for the benefit of present and future generations. To give effect to these rights in the context of air quality, the National Environmental Management: Air Quality Act, 2004 (Act No. 39 of 2004) (NEM:AQA) was promulgated to provide reasonable measures for the protection and enhancement of the quality of air in the Republic of South Africa, to prevent air pollution and ecological degradation, and to secure ecological sustainable development while promoting justifiable economic and social development.

Section 21 of NEM:AQA requires the Minister responsible for the environment (the Minister) to publish a list of activities which result in atmospheric emissions and which the Minister reasonably believes has or may have a significant detrimental effect on the environment, including health, social conditions, economic conditions, ecological conditions or cultural heritage. These identified activities are known as Listed Activities and companies require an Atmospheric Emission Licence (AEL) to conduct them. Section 21 further requires the establishment of Minimum Emission Standards (MES) for specified pollutants or a mixture of substances resulting from the Listed Activities.

Companies that could not meet the prescribed MES within the legislated timeframes could apply for the postponement of the compliance timeframes to the National Air Quality Officer (NAQO). During 2019, the NAQO received the last applications for postponements and suspensions to comply with the new plant standards and applications for Provisional Atmospheric Emissions Licences (PAELs). The NAQO granted some of the applications for postponement and suspension with the MES and some of the applications for PAELs, and refused others. These decisions led to a number of appeals, namely those seeking to appeal the NAQO's decisions to grant the applications and those seeking to appeal. Consequently, the Minister must consider various and conflicting grounds of appeal within the context of section 24 of the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996) and the socio-economic conditions in the country.

Owing to the complex nature of the issues arising from these matters, the Minister is of the view that a comprehensive consultative process is required to address the issues emanating from the various applications for suspension and/or postponement of compliance from the timeframes of the MES and/or for the issuance of PAELs. The Minister, acting in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA), invoked section 3A of NEMA to establish a National Environmental Consultative and Advisory Forum (NECA Forum). The purpose of the NECA Forum is to conduct an extensive consultative process with all interested and affected parties (I&APs), to assess and present relevant research and analysis for review and interrogation, and to develop a comprehensive report to the Minister on the outcome of the NECA Forum. The report will provide the Minister with practical solutions to resolve the issues arising in respect of the non-compliance with the MES, including the related appeals and applications for the issuance of PAELs.

The public participation process will entail public meetings and I&APs will have an opportunity to submit written comments and representations. A period from 15 October 2022 to 30 November 2022 is provided for all I&APs to review and submit comments regarding this process, the applications for postponement/suspension, including the related appeals and applications for the issuance of PAELs. All written comments and representations must be submitted by 30 November 2022. IsiGaba 24 soMthethosisekelo ka-1996 waseRiphabhuliki YaseNingizimu Afrika (uMthetho Nombolo 108 ka-1996) sihlizeka ngamalungelo aqinisekisa ukuphepha kwemvelo ukuze kubhekwe impilonhle yabantu futhi kuqikelelwe nanokuthi isizukulwane samanje nesangamuso sihlomula ngokufanele. Ukufezekisa la malungelo kwindikimba yomoya oseziningeni elingcono, kusungulwe uMthetho Wezemvelo Kazwelonke Ongamela Umoya Oyikhwalthi ka-2004 (uMthetho Nombolo 39 ka-2004). Lo Mthetho, usungulwe ngenhloso yokuhlizeka amazinga omoya aseziningeni elingcono kanye nokuqikelela umoya oyikhwalthi eNingizimu Afrika ukugwema ukungcoliseka komoya nokuncipha kwezinga lokuphilisanana kwemvelo futhi nokuqinisekisa ukusimama kwemvelo. Ngakolunye uhlangothi lo Mthetho, uqhakambisa intuthuko yenhlalo kanye neyezimali ezweni.

IsiGaba 21 soMthetho Womoya Oyikhwalthi Ongamela Ezemvelo Kazwelonke siphoka uNgqongqoshe obhekele imvelo ukuba ashicelele uhlu lwemisebenzi ezoba yingxenywe yokuphumelelisa ukusabalala kwezingcolisimoya emkhathini ngendlela ephile nenganabungozi. UNgqongqoshe ukholelwa ekutheni ukusabalala kwezingcolisimoya kunomthelela oyingozi, obandakanya izimo zempilo, zenhlalo, zemali, zemvelo mpiliswano kanye nezinto ezingamagugu ezihlomulisa amasiko. Imisebenzi enomthelela ekungcoliseni umoya yaziwa njengemiSebenzi Esohlwini, ngakhoke izinkampani kufanele zibe neZimvume Zokusabalalisa Izingcolisimoya Emkhathini ukuze kulawuleke le nqubo. IsiGaba 21 siphinde siphoke ukuqaliswa kwamaZinga Amancane Okusabalalisa Izingcolisimoya noma inhlanganisela yamakhemikhali eyingxenywe yezinto noma yemisebenzi esohlwini eholela ekungcoliseni umoya.

Izinkampani ezihluleka ukuhlangabezana namaZinga Amancane Amiselwe Ukusabalalisa Izingcolisimoya ngokuhambisa nezikhathi ezibekwe ngokusemthethweni, zingafaka izicelo maqondana nokuhlehlisa izikhathi ezibekiwe, kusiKhulu Somoya Oyikhwalthi Kuzwelonke. Izicelo zokugcina eziqondene nokuhlehliswa nokumiswa kweziMvume Zokusabalalisa Izingcolisimoya Emkhathini zagcina ukuthunyelwa kusikhulu esiqondene ngonyaka ka-2019. Ngemuva kwalokho, lesi sikhulu sabe sesinikezela ngeZimvume Zesikhashashana Zokusabalalisa Izingcolisimoya Emazingeni Amancane kwabanye abafakizicelo ngakolunye uhlangothi abanye abafakizicelo banqatshelwa ukuthola izimvume. Lokhu kwabangela ekutheni kube nezikhazazo kanye nemibuzo mayelana nonqamulajuqu wokunikezela ngezimvume. Kwaphinde kwaphoka ukuba uNgqongqoshe abheke izizathu ezahlukahlukene ezibangela ukungqubuzana kwezinqumo mayelana nokunikezelwa kanye nokunqatshelwa kwezimvume, ngokwesigaba 23 soMthethosisekelo WaseNingizimu Afrika ka-1996 (uMthetho Nombolo 108 ka-1996) kanye nangokwezimo zenhlalakahle nezezimali ezweni.

UNgqongqoshe ubona ukuthi kufanele kubekhona inqubo yokuxhumana ukuze kuxazululwe ingxagnxatheka yezinkinga edalwe ukufakwa kwezicelo ezahlukahlukene eziphathelele nokumiswa nokuhlehliswa kwezimiso zezikhathi ezibekwe ukuSabalalisa Izingcolisimoya Ngokwamazinga Amancane. Okungenani kufanele kubekhona inqubo yokunikezelwa ngeziMvume Zesikhashashana Zokusabalalisa Izingcolisimoya Emkhathini. UNgqongqoshe oyibamba ngokoMthetho Wokungamela Ezemvelo Zikazwelonke ka-1998, (uMthetho Nombolo 107 ka- 1998) (NEMA), uphakamisa ukuba isiGaba 3A soMthetho Wokungamela Ezemvelo Kuzwelonke usungule isiGcawu esizobhekela ukweluleka nokuxhumana mayela nezemvelo ezweni lonke. Inhlalo yesiGcawu Sokweluleka Nesokuxhumana Ngezemvelo Sikazwelonke ukulawula inqubo yokuxhumana phakathi kwezinhlangothi ezinentshisakalo kanye nalezo ezithintekayo, nokubuyekeza kanye nokwethula ucwaningo olwenziwe. Lokhu kuzosiza ukubuyekeza izinqumo ezithathwe maqondana nezimvume kanye nokuhlanganisa umbiko oqondene nomphumelo wesigcawu. Umbiko uzohlizeka uNgqongqoshe ngezixazululo eziphathekayo ekuxazululeni izinkinga mayelana nokungathobeli iziMiso Zamazinga Amancane Okusabalalisa Izingcolisimoya, okubandakanya izikhazazo nezicelo ezifakiwe zokunikezela ngeziMvume Zesikhashashana Zokusabalalisa Izingcolisimoya Emkhathini.

Ukubandakanywa komphakathi kuzobandakanya imihlangano yomphakathi kanti izinhlangothi ezinentshisakalo kanye nezithintekayo zizoba nethuba lokuphawula nokwethula imibono yazo. Izinhlangothi ezinentshisakalo kanye nezithintekayo zinethuba lokwethula imibono maqondana nale nqubo kanye nezicelo eziphathelele nokuhlehliswa nokumiswa kwezimiso zeziMvume Zesikhashashana Zokusabalalisa Izingcolisimoya Emkhathini.
